Apparently, we will not be getting an official resignation from William King. But, Greg's deadline to him has passed and so I am proceeding with an effort to bring the Board back to full membership. Before I ask the VCC and the BoS for new appointments, I want to ask you if you are willing, ready, and able to make the time commitment for advancing to a full Board membership at this time. If your answer is yes, I will advise the BoS accordingly. If the BoS appoint you, it would likely be for the remainder of Bill King's term to 6/30/09, subject to formal appointment by the BoS. I believe you would then be eligible for another two five-year terms after that. The BoS may or may not request another interview for your appointment as a full member. Please advise as to your intentions.
