

A memo had been sent on Oct. 18 to Mr. Murray by Ms. Fochtman with a recommendation from the Recreation Commission for restricted signage for the Skate Park parking. Mr. Calore noted that the problem will continue until tickets are issued. The High School parking lot is only 300 yards from the most distant field. b. Ms. Fochtman reported that ordinance studies are currently being conducted and found that one light had exceeded the brightness limit. Musco Lighting will need to return to make an adjustment to meet the lighting requirement ordinance.

Ms. Fochtman explained implementing a yearly user field fee per player to all leagues across the board so all users contribute to field maintenance. Currently, some user groups are not contributing to field maintenance at all. Town fields need to be improved across the board. A greener approach and soil improvement needs to be made. Ms. Fochtman also noted that higher cost field improvement items need to be funded with field fees, i.e. field lighting, bleachers, fencing. Mr. Schlegel would like to see more control and consistency in our Town fields and the fees collected would benefit each seasonal player regardless of where they play from one season to the next.

MOTION: Mr. Calore motioned, seconded by Ms. Jarsky, that leagues collect a yearly per person youth and adult league player charge of \$10 for Acton Leagues and \$15 for Non-Acton Leagues beginning in the Fall season of 2008 (Aug.)

MOTION: A motion was made by Mr. Benson, seconded by Ms. Jarsky to accept the above 2008 NARA Beach and NARA Youth Summer Program Fee schedule recommendations to the Board of Selectmen, approved 4-0.

DOG ISSUE DISCUSSION—Mr. Schlegel reported that he attended the BOS hearing on the NARA Park leashing policy. The BOS passed continuance on NARA Park's leash policy. Mr. Schlegel would like to recommend Morrison Farm as a potential Dog Park and a no dogs off leash policy on Great Hill Fields policy and if Morrison Farm constructs soccer fields, then Great Hill can become a dog park. Mr. Benson would like to

find an area for dogs as they are part of the family. Ms. Fochtman will draft a memo to the BOS regarding dog complaints at Great Hill. Mr. Schlegel would like to discuss Great Hill dog issues at the next meeting.
