**Project Description** Install a replacement SSDS in the back yard of the existing house. The area is within the 100-foot buffer zone of bordering vegetated wetlands as flagged and shown on Plan No. 2416. The design of the SSDS falls under 310 CMR15.000 (Title 5) and the Acton Board of Health Regulations (Article 11).
