7:15 ANRAD - 442 Massachusetts Avenue (010, 011)

Ben Ewing, from Stamski & McNary presented an ANRAD plan. Mr. Ewing reported that Dave Crossman from B & C Associates delineated the wetland line; the wetlands exist off-site but the 100' buffer zone crosses onto this parcel.

Upon query by Ms. Portante, Mr. Ewing reported that the site is currently a single family house on a residential lot.

Ms. Lee reported that during the site walk with Mr. Tidman, she had questioned the delineation, based on the existing vegetation and topography in the southern corner; Mr. Tidman went back to the site with Dave Crossman and took soil samples which proved that the area she questioned was not Bordering Vegetated Wetlands. Hence, the delineation is correct as shown.

Upon query by Mr. Maitland, Mr. Ewing reported that he is unsure of any future plans for the property; the applicant has only filed for the delineation at this time.

Ms. Ristine also reported that Mr. Tidman confirmed that the existing vernal pool (off site) is 140' away from this parcel.

7:21 Hearing no further questions, Mr. Maitland closed the hearing.


Ms. Portante moved that the Commission accept the minutes for January 16 and February 6, 2008, Ms. Lee 2<sup>nd</sup>; unanimous.
