7:00 Request for Determination - 18 Wheeler Lane - Nashoba Brook Conservation Area (010)

Town of Acton Natural Resources Dept. - removal of trees from the Robbins Mill Dam (headwall) to comply with recommendations of the 2010, 'Tighe & Bond' dam evaluation report. Work will occur within 100' of wetlands and within the inner riparian zone of Nashoba Brook (Town Atlas Plate D-5, parcel 6).

Mr. Tidman reported that the Commonwealth Department of Conservation & Recreation, Office of Dam Safety requires that the Town take steps to make the Robbins Mill dam safe. Tighe and Bond has completed a Phase I dam safety report recommending that all trees on the head of the dam and a distance of 20' at the bottom of the dam be removed as a first step.

Upon query by Mr. Froberg, Mr. Magee noted that saving the dam provides valuable still water habitat.

Mr. Tidman noted that if the Town breached the dam it would be quickly restored by beavers.

Ms. Portante suggested that the Town breach the dam and let nature take its course.

Mr. Magee noted that the trees would have to be removed regardless of beaver activity.

Mr. Magee noted that the trees would have to be removed regardless of beaver activity and would obviously be removed if the dam itself was removed.

Upon query by Mr. Maitland, Mr. Tidman reported that, weather permitting, the work will occur this winter (2010/2011).

Determination - 18 Wheeler Lane - Nashoba Brook Conservation Area

Mr. Magee moved that the Commission find the work described in the Request is within the Buffer Zone, as defined in the regulations, but will not alter an Area subject to protection under the Act. Therefore, said work does not require the filing of a Notice of Intent.

Ms. Portante 2nd, the motion passed with five ayes and one abstention - Bill Froberg.

Ms. Portante moved that the Commission issue a Certificate as recommended by Mr. Tidman, Mr. Magee 2nd; unanimous.


