Hello CPC Members-

**Specific Request:** On behalf of the Morrison Farm Committee, I request an extension of the deadline for filing an application from 11/26/12 to 12/17/12.

Attached are three documents:

1. Our most recent update presentation, dated 11/5/12, to the BoS;
  2. A map that shows how we are working on a "usage swap", with the following components:
    - a. Re-designating about 1.8 acres of land around the Robbins Memorial (that currently cannot be used for burials) from cemetery use to historic preservation use;
    - b. Re-designating about 2.0 acres of land at the rear of the Morrison Farm area (that is able to be used for burials) from general municipal to cemetery use.
  3. A rendering of our current thinking about the development of the front portion of Morrison/Robbins/Ice House Foundation areas; caution: this is a draft that has already changed a bit, but you will get the idea.
- Obviously, there is a lot to talk about here, but your accommodation of the Morrison Farm Committee/BoS's schedule is critical to our success.
  - The BoS will be reviewing and voting on our final presentation on December 3, 2012;
  - After that vote, we will then finalize all aspects of this complex presentation, including substantial cost projection, architectural, landscape architectural, design and engineering renderings/pans.
