Notice of Intent 148 Willow Street

The property at 148 Willow Street consists of 2 parcels in common ownership. The total property area is approximately 11 acres but the developed portion of the property is limited to 1 acre containing an existing single family home in an area along Willow Street. The orthophoto below depicts this area.



The applicant proposes to construct a new subsurface sewage disposal (septic) system to serve the existing single family home. The system will be located entirely within the existing lawn area and alterations will be offset 50 feet from the wetland resource area which is located near the extent of the existing lawn area.

Wetlands on the property were delineated by Acton Survey & Engineering during soil testing and field services for the design of the septic system. The wetlands were found to be located near the toe of the slope defining the lawn area. An auger was used to confirm the placement of wetland flags W.F. 1 through 4 based on the presence or absence of hydric soils.

The project is limited to the replacement of the septic system. The system has been designed to meet or exceed the minimum requirements specified in 310 CMR 15. Wetlands Program Policy 86-1 establishes the presumption that the system will protect the Interests identified by the Act. Erosion barriers will be installed at the limit of work to ensure there will be no adverse impacts to the wetlands during construction of the system.




USGS MAP
