This is an item for 6/23 agenda, assuming that is when the BOS will do the en masse Town committee reappointments, to be effective 7/1: BOS should approve simultaneously the ACHC's membership-makeup change from 7 voting, -0- associates, back to 5 voting, 2 associates.

You will recall that ACHC had had the 5-2 membership for years, and then learned a couple of years ago that the 2 associates were unauthorized and would require an amendment of the Town charter, etc. There was no limit on the number of voting members, so while waiting for the year-long amendment process--2013 Town Meeting vote and local ballot vote in 2014--ACHC, with BOS approval, switched to 7 voting.

With the newly authorized 2 associate positions, ACHC wants to resume the 5-2 membership. If and when there is a need for more voting members, the BOS may approve at that time.
