DATE: August 7, 2014

The Acton Board of Selectmen, as the Hearing Authority under General Laws Chapter 140, §157 has received a written complaint about the dog, known as "Faulk", that you own and house at 18 Strawberry Hill Road, Apt. 20F, Acton, MA 01720 (the "Dog"). Thus pursuant to the provisions of Massachusetts General Laws, Chapter 140, §157, the Acton Board of Selectmen (the "Board") orders that Ms. Tiffany Brown ("Ms. Brown" or "you") of 18 Strawberry Hill Road, Apt. 20F, Acton, MA 01720 **appear at a hearing before the Board at 7:15 PM on September 8, 2014**, in the Frances Faulkner Hearing Room on the third level (Floor #2) of the Acton Town Hall, 472 Main Street, Acton MA 01720, **and show cause** as to why the Board should not determine the Dog to be a Dangerous Dog as defined in the General Laws (enclosed) and order appropriate action be taken as a result, including the possibility of humanely euthanizing the Dog. A "Dangerous Dog" is defined as

A dog that either: (I) without justification, attacks a person or domestic animal causing physical injury or death; or (II) behaves in a manner that a reasonable person would believe poses an unjustified imminent threat of physical injury or death to a person or to a domestic or owned animal. G.L. c. 140 §136A.

The Board's investigation into whether the Dog should be deemed a Dangerous Dog shall inquire about the facts relating to the incident occurring on April 2, 2014, and May 31, 2014 that allegedly was an aggressive attack by the Dog causing bodily harm. You have the right to be present at the hearing, to have counselor or representative of your own choosing present for the purpose of advising you, and to speak on your own behalf. You and other witnesses may be called by the Board and/or its representative to testify at the hearing. You are invited to cross-examine these witnesses and to call witnesses of your own, who shall then be subject to cross-examination by the Board and/or its representative.

Copies of the complaint and other materials from Mr. Tack Palmer, the Town's Animal Control Officer, and a copy of the Massachusetts General Laws, Chapter 140, § 157, are attached for your information.

On May 31, 2014, I, Officer Erin Corey of the Sudbury Police Department, responded to the Willis Lake beach area for a report of a dog bite.

Upon arrival I met with the victim's father, Michael Elkort (DOB 9/3/66) who stated his daughter, Eve Elkort (DOB 6/7/00) was attacked by a dog down at the beach. Eve lifted up her shirt and showed me where the dog bit her. On Eve's left back side, there were two marks that appeared to be teeth marks. The area also showed the skin to be red and raised. There was mild breakage of the skin. The dog had also ripped through the jacket that Eve had been wearing. The dog had also thrown Eve to the ground. Eve was visibly upset and shaken up by this incident. Michael stated he was doctor and did not require an ambulance but would have Eve checked out by her physician.

The owner of the dog, Tiffany Brown (DOB 8/14/91) had all her dogs locked up in her vehicle. Tiffany stated that her 4 year old neutered german shepherd, Faulk, had jumped on the back of Eve. Tiffany then used her electric collar remote control to zap Faulk. Faulk then returned to Tiffany. Tiffany also had two other dogs with her, Isis (8 months old, golden mix) and Brianna (Aussie Kelpie). Jeremy Murray (DOB 6/11/88) was also with Tiffany when this incident occurred. Tiffany stated that all the dogs are licensed with the Town of Acton except Isis. She states she recently adopted Isis.

Other witnesses on scene were Judith Kendall (DOB 9/2/69), Kaylee Kendall-Beagan (DOB 10/24/89), Allegra Schejtman (DOB 8/2/00), and Catherine Haley (DOB 5/19/00). All stated that the German shepherd attacked Eve and pushed her to the ground. They all stated that the dog bit her.

This report will be forwarded to Jen Condon, the dog control officer of Sudbury.



On May 31, 2014, I, Officer Erin Corey of the Sudbury Police Department, responded to the Willis Lake beach area for a report of a dog bite.

Upon arrival I met with the victim's father, Michael Elkort (DOB 9/3/66) who stated his daughter, [REDACTED] (DOB 6/7/00) was attacked by a dog down at the beach. Eve lifted up her shirt and showed me where the dog bit her. On [REDACTED] left back side, there were two marks that appeared to be teeth marks. The area also showed the skin to be red and raised. There was mild breakage of the skin. The dog had also ripped through the jacket that [REDACTED] had been wearing. The dog had also thrown [REDACTED] to the ground. [REDACTED] was visibly upset and shaken up by this incident. Michael stated he was doctor and did not require an ambulance but would have [REDACTED] checked out by her physician.

The owner of the dog, Tiffany Brown (DOB 8/14/91) had all her dogs locked up in her vehicle. Tiffany stated that her 4 year old neutered German shepherd, Faulk, had jumped on the back of Eve. Tiffany then used her electric collar remote control to zap Faulk. Faulk then returned to Tiffany. Tiffany also had two other dogs with her, Isis (8 months old, golden mix) and Brianna (Aussie Kelpie). Jeremy Murray (DOB 6/1/88) was also with Tiffany when this incident occurred. Tiffany stated that all the dogs are licensed with the Town of Acton except Isis. She states she recently adopted Isis.

Other witnesses on scene were Judith Kendall (DOB 9/2/69), Kaylee Kendall-Beagan (DOB 10/24/89), [REDACTED] (DOB 8/2/00), and [REDACTED] (DOB 5/19/00). All stated that the German shepherd attacked [REDACTED] and pushed her to the ground. They all stated that the dog bit her.

This report will be forwarded to Jen Condon, the dog control officer of Sudbury.
