**TOPIC: JONES PLAYGROUND DISCUSSION**

<b>DISCUSSION</b>	A draft of the Jones Field Playground Survey was circulated for review. Various means of survey distribution were considered including fliers, the "Action Unlimited," posting to community boards, Survey Monkey, Acton Family Network (AFN) and a possible online incentive. The appeal of the various playgrounds to differing age groups and needs was discussed. Potential improvements to Jones and related costs were considered, including sand and water. Ms. Rier noted that donated bricks and the bench will remain although they might be moved. She suggested locating equipment appropriate to younger children nearer to the parking lot, opposite the present design. Ms. Phaneuf voiced the desire for sanitary facilities, running water and trash removal. Other South Acton alternative playground areas were discussed, including Great Hill, because Jones Field flooding is a concern. Little Great Hill is too remote from the parking area for small children. Mr. Will suggested the end of the Assabet River Rail Trail as a viable playground location. Ms. Fochtman described plans to improve the Ice House Pond and potential to have an East Acton playground there.
<b>ACTION ITEM</b>	Ms. McKeever-Matz will contact the Superintendent of Acton-Boxboro Schools regarding distribution through the school system. Ms. Rier will create a Facebook page.

**TOPIC: NARA MASTER PLAN**

<b>DISCUSSION</b>	Ms. Fochtman described A Ten-Year NARA Master Plan currently in development as the result of CPA feedback. NARA users will be surveyed. The Plan will contain more detail than the Open Space and Recreation Plan. Participation of the Recreation Commission in this process is requested.
