Interviews:

James Snyder-Grant is the current chair of the Acton Land Stewardship sub committee since September 2003. Andy Magee, Chairman of the Conservation Commission remembered that the Board of Selectmen requested that any chairman of the Land Stewardship sub committee be an Associate Member of the Conservation Committee.

Mark H. Eisenberg saw an article in the Acton Beacon in September stating that the Cable Advisory Committee wanted new members. He has a communications background and would like to serve on this committee. Mark moved to Massachusetts from Georgia in August 2003 and has three children in the high school – a 17 year old boy, a 15 year old boy and a 14 year old girl. 
The meeting was adjourned at 7:50 pm. The next meeting will be held on December 8, 2003 at Town Hall, if we have applications.
