

THIS REPORT IS IN REGARDS TO A REQUEST FROM LAUREL GHOSE OF 5 FAULKNER HILL RD. MRS. GHOSE EXPRESSED CONCERNS REGARDING THE LACK OF A SPEED LIMIT SIGN, AND A CHILDREN SIGN ON FAULKNER HILL RD. MRS. GHOSE INDICATED IN HER LETTER THAT THERE HAS BEEN AN INCREASED NUMBER OF CHILDREN IN THE NEIGHBORHOOD. I HAVE DISCUSSED MRS. GHOSE REQUEST WITH THE ENGINEERING DEPT., AND THE FOLLOWING IS OUR RECOMMENDATION. ONE CHILDREN SIGN SHOULD BE INSTALLED IN THE AREA OF MRS. GHOSE RESIDENCE. THE TRAFFIC ON FAULKNER HILL ROAD IS PREDOMINATELY THE RESIDENTS OF THE NEIGHBORHOOD. THE CHILDREN SIGN WILL REMIND THEM OF THE POTENTIAL CHILD IN THE STREET.


Dear Mr. Cowan,

We are residents of 5 Faulkner Hill Road in Acton. We have safety concerns for our children and other children who live in our neighborhood. There is NO speed limit posting for Faulkner Hill Road. Cars seem to be traveling faster than we consider a safe speed. We received notice on May 15, 2004 from the Town of Acton for plans to restore the pavement of Faulkner Hill Road. It is inevitable that cars will be traveling even faster after this is completed.

We are requesting that a speed limit sign and a "slow children" sign be posted on Faulkner Hill Road before a tragedy occurs. We would like to discuss these concerns with you.
