This Tuesday, October 21st at 7:45pm, the Planning Board will review a proposed zoning amendment that if approved would allow drive-through windows for pharmacies by special permit. At this hearing, the Planning Board will vote whether or not to recommend the proposed amendment for inclusion in the 2014 Fall Special Town Meeting.

The Kelley's Corner Steering Committee, at its October 8, 2014 meeting, voted to recommend to the Planning Board that consideration of this amendment, at least with respect to the Kelley's Corner zoning district, be postponed until after the ongoing Kelley's Corner Improvement
