Lisa: Please add to the agenda for 10/17 the following:

1. Vote to change the membership of the Kelley's Corner Steering Committee to include one member from Acton 2020 and two at-large members, as well as members from the FinCom, the DRB, the PB, and the EDC.

This changes the current KCSC charge, which requires three members from Acton 2020. The Selectmen voted on July 11 to reduce the membership of Acton 2020 from seven to five and that Committee currently only has three active members. The two at-large members would allow for greater flexibility in appointing KCSC members.

2. Vote to appoint Bob VanMeter as an at- large member of the KCSC.

3. Vote to appoint me as an associate member of the KCSC. The KCSC's charge requires a Selectmen as an associate member, according to the VCC's membership list. I am currently only the Selectmen's liaison to the KCSC.
